IN THE MATTER OF an Application dated May 1, 2008 by the New Brunswick System Operator for the Approval of Changes to the Open Access Transmission Tariff.

ORDER

WHEREAS:

- 1. New Brunswick System Operator ("NBSO") is required pursuant to Section 111 of the *Electricity Act*, Chapter E-4.6, R.S.N.B., 1973, (the "Act") as amended to make Application to the New Brunswick Energy and Utilities Board (the "Board") for approval of changes to the Open Access Transmission Tariff (the "Tariff"); and
- 2. NBSO has filed an Application and supporting Evidence with the Board for approval of changes to the Tariff; and
- 3. NBSO has filed a request that the Board issue an Interim Order pursuant to Section 40 of the *Energy and Utilities Board Act*, Chapter E-9.18, R.S.N.B., 1973, approving changes to the Schedule 1 rates, to be effective from the date of such Interim Order until further Order of the Board; and
- 4. NBSO has filed an Affidavit in support of its request for an Interim Order.

NOW THEREFORE IT IS ORDERED THAT:

- a) A Pre-Hearing Conference shall be held on June 4, 2008, commencing at 9:30 o'clock in the morning at the Delta Brunswick Hotel, Ballroom "C", Saint John, New Brunswick. A public hearing will be held on June 11, 2008, commencing at 9:30 o'clock in the morning in the same location to consider the Motion. Intervenors and the Applicant should attend the Pre-Hearing Conference to make representations to the Board with respect to;
 - the date of the public hearing to consider the application;
 - the procedure to be followed prior to and at each of the two public hearings; and

- any other matters in respect thereto.
- b) The Application, supporting Evidence, and the Affidavit in support of the Motion for an interim order, as well as a copy of the Board's Order, shall be placed on file for examination by interested Parties, during normal business hours in the offices of the Board and in the Applicant's business office.
