

THE NEW BRUNSWICK ENERGY AND UTILITIES BOARD

IN THE MATTER of a hearing to Review Enbridge Gas New Brunswick's Market Based Formula

Order

WHEREAS the New Brunswick Energy and Utilities Board (the "Board") in its two decisions of April 9th, 2008 directed that Enbridge Gas New Brunswick ("Enbridge") would participate in a technical conference and thereafter a generic hearing to examine all of the elements in the market-based formula used to derive the rates charged to customers;

AND WHEREAS the technical conferences are now concluded and a generic hearing is required;

AND WHEREAS the Board considers that customers and interested persons should be aware of the aforementioned hearing;

NOW THEREFORE IT IS ORDERED THAT:

1. Enbridge shall appear at the Board's offices on Wednesday, April 22, 2009 at which time a review of the market based formula will be conducted.
2. Enbridge shall file, in accordance with the Notice annexed to this Order and marked as "A", the appropriate financial and market information which will permit a thorough examination of the said formula.
3. Notice of this proceeding shall be included with the first bill for each of Enbridge's customers issued after the date of this order.
4. Enbridge shall also provide a copy of the attached Notice to all gas marketers, to all individuals who registered as intervenors in the rate applications of November 5th, 2007 and December 19th, 2007 and to all individuals who participated in the technical sessions described herein.
